The outside packing will change. A double-waved carton box will be used to ensure more stability during shipment. Moreover, the customized tray has an improved maximum baking temperature. From up to 50 degrees Celsius for the standard tray, the maximum baking temperature for the customized tray is up to 150 degrees Celsius.

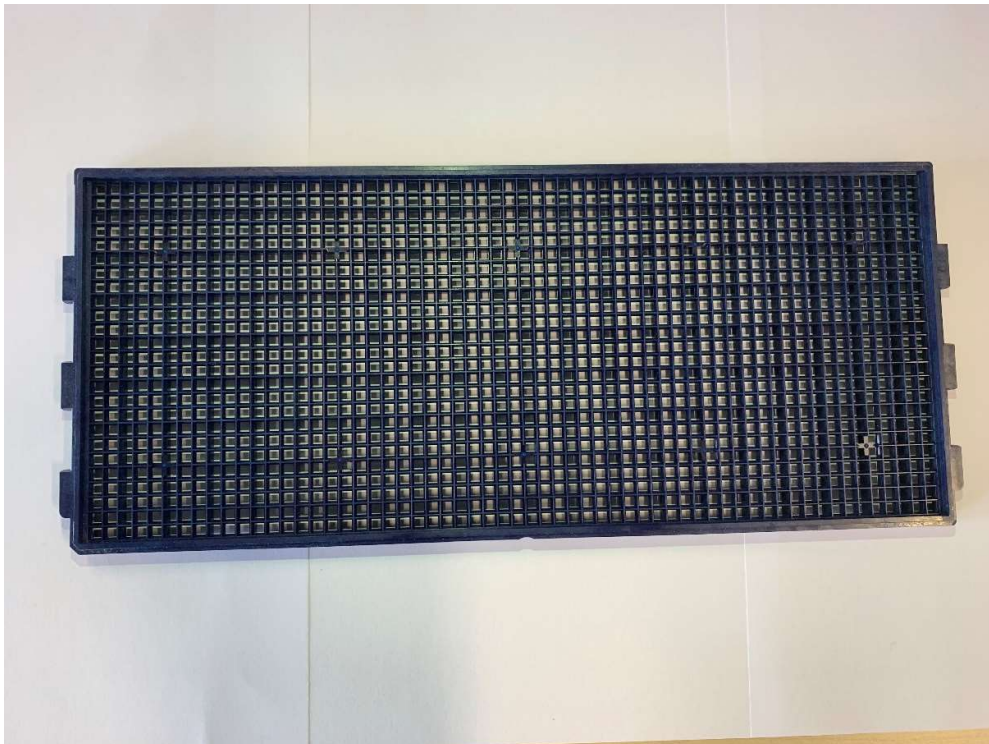

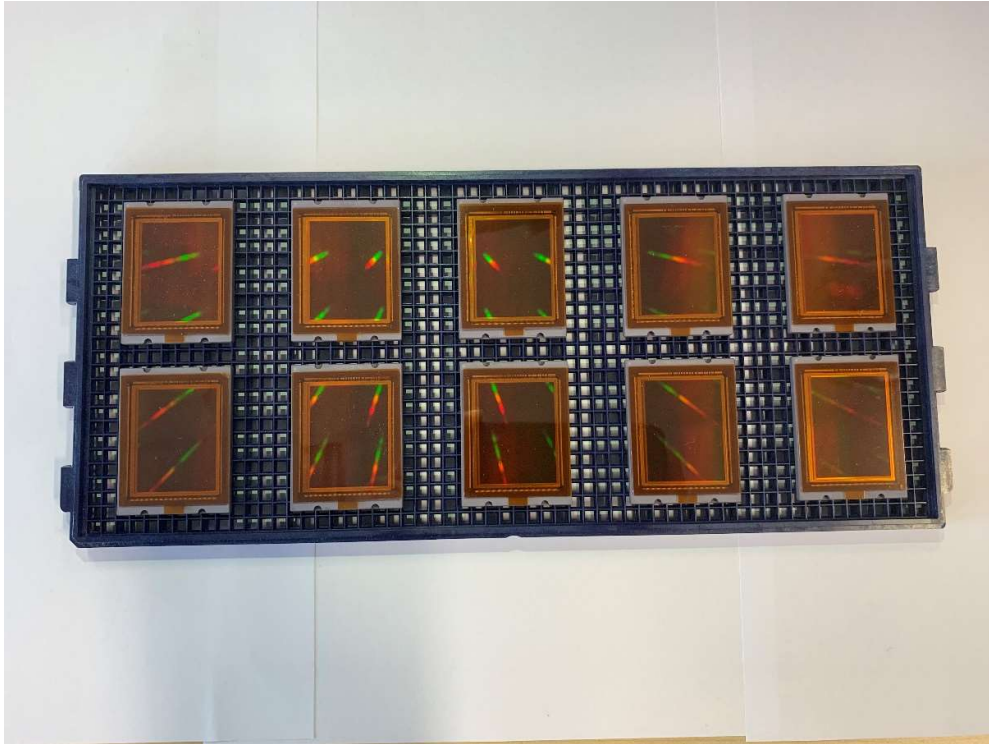
